COUNCILMAN VIEWS AND COMMENTS

Greetings neighbors. The State (SDAT) now has the data available for property sales for 2007. In the Berwyn/Branchville neighborhood during 2007, 15 single family detached homes were sold, at a median sales price of \$374,000 and an average sales price of \$376,000. Only one townhouse was sold at a sales price of \$330,000. The highest sales price was \$500,000 and the lowest was \$245,000, which was for a teardown, in the sales involving detached single family homes. We had 21 condominium sales at the Oasis (an apartment conversion project), at unit prices ranging from \$190,000 to \$272,400. In both 2005 and 2006 we experienced 31 sales of single family detached homes at median prices of \$337,500 and \$366,000, respectively. In 2005, six townhouse units sold at a median price of \$264,000 and in 2007 only two townhouse units sold at a median price of \$314,000.

Almost 3,000 homes in the Greater Washington, DC area are for sale as a result of foreclosure, including four in College Park, which includes one in Berwyn. There are about 100 homes for sale in College Park now. The number of homes for sale for over \$400,000 is about same as the number of homes for sale for less than \$300,000, about 20 of each.

It has just come to my attention that the County Planning Department has recently approved a new subdivision plan which creates a new buildable lot on the north side of the 4700 block of Pontiac Street, from the rear yards of two properties which front on 48th Avenue. The new lot would be located between the office building parking lot and the existing homes.

JPI West has finally accepted the District Council's Final Order with Conditions from last November. The proposed project has been approved for 220 residential units and 25,000 square feet of retail space on a site which used to have Lasick's Restaurant and the Hillcrest Hotel. Also, the County Planning Department recently approved a Buffalo Wild Wings Restaurant (a 6,500 square foot sports bar) for a pad site in front of the development to the north of Ikea. Construction of the Mazza GrandMarc Apartments (grad student housing) should begin this spring, with completion

projected by fall 2010. The project is located on the west side of Route 1, just south of the Post Office.

On Saturday, April 5th and April 12th the elected body and City Staff will meet to discuss the City Manager's proposed budget for FY2009. In past years the meetings were also broadcast over the City's cable channel. I expect that will be the case this year, too. We probably will not receive the budget until about March 22nd, so it is too early to give you a preview of what it proposes. However, by the potluck supper, I will have had time to do some review of the 200 page budget.

I hope to see you at the potluck supper on Saturday, the 29th.

CITY COUNCIL MUSINGS

Just a short note this month. City council has been doing normal stuff. Listening to the mayor tell us about 'free money' and future debt of the city. Getting ready for the new budget for the next fiscal year. We listed to four bar owners tell us how they will change the way they operate and attempt to comply with local law and regulations. We have had a number of executive sessions – which are closed to the public – and supposedly briefed on upcoming and current negotiations. (If I tell you about them, I'll have to kill you.) Needless to say, I do not believe all of them were/are necessary.

College Park now has a Historic District – roughly the area behind the Book Exchange south to Calvert Road, all the way to the railroad tracks – 'Old Town' as it is called. I'm glad that I don't own property in that neighborhood.

We have heard about development on Route 1 for student housing and a buffalo wings and ribs establishment in the Ikea area. Quality dining has come to College Park. The owner of the Santa Fe wants permission to allow under 21 students in his

'venue' – to reach a larger portion of the student body says he.

The city has taken delivery on one of the three new trash trucks. You will notice it as it is larger than what we now use. Single stream recycling is now in place in some neighborhoods. When it comes to Berwyn, you will be notified.

I finish up with some advice: call parking if you see a violation. Call code enforcement to report a suspected code violation. Let them decide if there really is a problem. If you have a question about trash (solid waste) or recycling, call public works before 4 pm. If your street light is out, call Pepco. It's automated but you'll need the number off of the light pole and your street address. Bag yard waste in paper bags or in city-approved containers and set it out with your regular trash. Bulky trash requires a call to public works, but they will come and pick it up. My dad always said, "If you live on a dirty street, you didn't have anybody to blame except the person in the mirror!"

May God continue to bless this great nation. We will look for you at the Pot Luck – no Thursday meeting this month.

From Major Davis of the PG Police:

College Park Friends,
As many of you may know, we experienced citizen robberies throughout College Park from February 18–22. In each case, female victims were robbed by force and/or knifepoint of their purses or backpacks at the following locations:

- 5300 block of Lackawanna Street (near the Metro) - Hollywood
- 8100 block of 48th Avenue – Berwyn
- 4900 block of Berwyn Road – Berwyn

The robbery suspects and their getaway vehicle were described in detail by our victims. My Robbery Suppression Team detectives tracked the use of a credit card taken from one of our victims to a Route 1 hotel late Friday night / Saturday morning. An operational plan to apprehend the suspects terminated after the suspects fled from their getaway vehicle and were captured by my Special Assignment Team officers and Robbery Suppression Team detectives.

Four juveniles (2 from Washington, D.C., 1 from Landover, and 1 from Lanham) and one adult (Juan Carlos Cortez of 20th Avenue in Hyattsville) were charged that night with Robbery with a Deadly Weapon, Theft, and Possession of a Stolen Vehicle

(...the getaway vehicle). A great end to these capers for the community!

Other items of interest over the weekend of Feb. 23-24 include a residential burglary arrest along the 4900 block of Blackfoot Street in Hollywood. Two adults (Gerald Archery of Greenbelt and Dwight Jeffries of College Park) were arrested by College Park contract officers during a burglary in progress called into the PGPD by an observant and conscientious citizen. Great job by all!

Five side-view mirrors of vehicles were destroyed by unknown vandals along the 8300–8400 blocks of Potomac Avenue in Berwyn. Two car windows were smashed in Hollywood (Lackawanna Street and Huron Street) as well by an unknown suspect. These property crimes remain unsolved, and anyone with information is asked to call 301-699-2601 (District I Investigative Section) or 1-866-411-TIPS (Crime Solvers) with information. Remember, these cowardly vandalisms are usually committed by wayward kids who commit several at one time. So please call right away at the first sign of disorder in the neighborhood.

Overall, a very busy weekend with seven criminals who were preying on College Park are now in custody. These arrests were facilitated by community partnerships that remain the key to the elimination of criminal activity in our neighborhoods. I'm very proud of my officers as well. Their dedication is something that I see demonstrated each and every day. Thank you.
